ABOUT THE COURSE

The program is a complete, professionally taught Driver Education Course that will provide students with a comprehensive introduction to the driving experience. Students must complete 24 hours of classroom instruction and 24 hours of in the car driving instruction related to “Rules of the Road”.

WHAT THE COURSE OFFERS

Includes the MV285 “Student Certificate of Completion” : an insurance reduction to students who qualify ; Seniors driver’s license Class D at age 17 upon passing the road test from the Department of Motor Vehicles.

ELIGIBILITY

Students must be 16 years old and must have a Learner’s Permit before the first class (6/29/09). Students must reside in the North Shore School District and have completed their sophomore year of High School.

ABSENCES/MAKE-UPS

By New York State Education regulations, a student is allowed to make up no more than 3 absences. It is the student’s responsibility to make arrangements with and obtain prior approval from the regular driving and/or lecture instructor to proceed with any make-up assignments. More than 3 absences will result in the student being dropped from the program. No exceptions.

STUDENT OBLIGATION FORM

1. I will always obey New York State Vehicle and Traffic Laws.
2. I will obtain a New York State Learner’s Permit.
3. I understand that I must successfully complete the theory and road class portion of the course in order to receive a Certificate of Completion.
4. I understand that to successfully complete the course, my attendance is essential to fulfilling minimum State requirements.
5. I have read the Absence/Make-up section of this application
6. I understand that to practice my driving skills without my instructor, I must have a Learner’s permit (MV-100) and I can only practice with my Parent/Guardian between the hours of 5:00am and 9:00pm.
7. I understand the Operator’s Privileges are obtained at age 17 with a successful completion of the 48-hour Driver Education Course and passing the road test.
