North Shore Schools Board of Education Town/Regular Meeting Minutes October 26, 2017

The meeting was called to order by President Antoinette Labbate at 6:30 p.m. in the High School Library. Present were Trustees Berliner, Commander, Galati, Jones, Ludmar and Russo. Also present Superintendent Dr. Peter Giarrizzo, and Assistant Superintendents Olivia Buatsi & Rob Chlebicki.

At 6:30 p.m. on motion of Trustee Berliner and seconded by Trustee Russo and all in favor, the Board moved to convene an executive session in room H4 in the high school to discuss matters regarding collective negotiations pursuant to Article 14 of the Civil Service Law (the Taylor Law) and discussions regarding proposed, pending or current litigation.

At 7:40 p.m. on motion of Trustee Ludmar seconded by Trustee Galati and all in favor, the Board moved to come out of executive session and resumed the meeting in the library. There were approximately 75 people in the audience.

Pledge of Allegiance

President Labbate led the audience in the Pledge of Allegiance.

Board Recognition

On behalf of all of the parent organizations, Coordinating Council Presidents, Lisa Vizza and Denise Reiner, recognized the Board of Education for their commitment to the children and residents of the North Shore community. Under the direction of music teacher Jason Domingo, the Chamber Orchestra performed, high school teacher Teresa Paolilli-Schiano, presented the Board with ties and tiebags made from repurposed material by students in the advanced fashion class, and a celebration was held with refreshments hand-made by middle and high school students in the culinary arts and middle school elective classes.

President Labbate thanked Lisa Vizza and Denise Reiner, the students, faculty and everyone involved for the lovely presentation. She also thanked her fellow trustees for the many hours they devote to working hard for the community they serve.

Report from the SGO

SGO co-presidents Lindsay Golden and Emilie Biolsi reported on events and activities at the high school, including: 14 members of the SGO attended the recent CASA meeting and found the statistics of substance abuse very scary. They want to make a difference and spread the word. They are interested in getting a class together to become certified in the use of Narcan. They also reported that the recent presentation by LICADD was very helpful and classmates left feeling very motivated. The SGO is glad to be involved with Shared Decision Making and feel they can make a positive impact. Finally they reported that the Women's Soccer Team have made it to the play-offs; the first game is Friday @2:30 p.m.

Report of the Superintendent

Dr. Giarrizzo reported on his first round of "learning walks" with each of the five principals. These have given him opportunities to tour the schools, visit classrooms, and talk about building goals and objectives. He reported that our principals are working with focus and purpose, teachers are

engaged with children, the purpose of the lesson has been clear without explanation, and most importantly, teachers and students are enjoying one another. Dr. Giarrizzo reported on the first of seven planned "coffee and conversations". The turnout was excellent and the conversations were thought provoking and focused on the right priorities. A range of issues were discussed including homework, wellness, social-emotional learning, reducing stress, the importance of play, strong outcomes for our high school students, and balancing accountability with good and purposeful teaching, learning, and assessment practices. The next meeting is scheduled for November 14th and the first evening session is scheduled for that day as well. Dr. Giarrizzo thanked Mr. Chlebicki for his leadership with administrators in further defining and understanding the SVOs. Dr. Giarrizzo reported on the CASA event on Monday, which was well attended and very effective. He felt the key outcome from the meeting is that we need to start the conversations surrounding substance use and abuse much sooner and the focus will be to identify appropriate ways of doing that. Dr. Giarrizzo thanked Coordinating Council and students for contributing to Board recognition night, and thanked the Board for their hard work and partnership. He reported that at this evening's meeting there will be an update by the LAC committee and he thanked Chairperson Deb McDermott for her leadership and the entire committee for their focused work. Also on the agenda, a report from the elementary principals and directors on student achievement at the elementary level. Finally as a follow-up, he reported that there will be a meeting of the Athletic Attendance Policy Committee in November which he and Don Lang will co-chair; he will report back on the progress of the meeting but noted the policy does not apply to students at the middle school.

Approval of Minutes

On motion of Trustee Jones and seconded by Trustee Berliner and all in favor, the minutes of October 12, 2017 were approved.

Town Meeting

President Labbate opened the floor for questions and comments from the public.

Denise Reiner, Glen Head, asked that the district share information with the CASA organization on what is incorporated into the curriculum on substance use and abuse, so as not to duplicate plans. Dr. Giarrizzo responded, the principals are preparing something for him, which he will share with the CASA group. Ms. Reiner suggested putting together a list that goes back a few years. President Labbate noted that we are fortunate to have Ms. Reissa Berg on our staff, considering her wealth of experience. She went on to say that at the last Board meeting parents in the community raised concern over the culture of acceptance surrounding alcohol use in the community; she suggested using that as a starting point for planning events. Trustee Commander added the CASA Board has discussed reaching this issue through a Parent University.

With no further questions or comments from the public, President Labbate closed the town meeting.

Report on Student Achievement

The three elementary principals, Lori Nimmo, Bridget Finder, and Christopher Zublionis, along with Director of Elementary STEAM, Carol Smyth and Director of Elementary Humanities, Devra Small, presented an overview of testing data from the ELA and math & science assessments. Data from math assessments indicate students continue to show growth with respect to content knowledge, conceptual understanding, facility with skills, and the ability to solve problems. Results from the NYS fourth grade

science assessment suggest our students' strong content knowledge and facility with skills. It also indicates that we are reinforcing the opportunities the newly adopted NYS Science Learning Standards and our enhanced efforts around STEAM learning offer for enhancing student learning in STEM. In the area of ELA, North Shore's student proficiency percentages are in the top fifth of Nassau County districts and typical for districts similar to ours. Our students show strength in all standards and especially in writing. Each school principal also reported on how student achievement is measured through the Shared Valued Outcomes (SVOs). In Glen Head, this is being accomplished through the ilnnovate program. Innovate was implemented to provide opportunities for students to practice and commit to the application of all of the SVOs to solve real-world problems. They not only mastered new STEM skills but also increased their facility as Communicators, Collaborators, Thinkers, Problem Solvers, Innovators and Committed Individuals. In Glenwood Landing the system of Authentic Learning Experiences at every grade level is being used. Several grade levels are participating in Performance Assessment Design Initiative (PADI) projects and others are designing their own experiences within the curriculum including: the investigation of purposeful play, a comparison of life long ago with life today, an inquiry as to whether or not balance is essential, an exploration of how emotions impact learning, an investigation of how artists and scientists work to analyze and bring awareness to real-world problems. Students at Glenwood have the opportunity to engage in inquiry-based lessons in the Outdoor Classroom, Japanese garden and STEAM laboratory, all designed by teams of students within authentic learning experiences. Sea Cliff students participate in authentic conversations. Teachers in Sea Cliff designed conversations in strategic ways for each grade level. Examples included Socratic Discussion to develop communication and thinking skills for lower grades while the older students engaged in inter-active role playing to empower students to solve relational issues that develop amongst students. Before and after all of the experiences, students engage in pre-assessments and post-assessments to illustrate how students grew because of the experiences. They also reflected upon their own growth using learning progressions.

President Labbate thanked the principals and directors for the detailed and informative presentation. Dr. Giarrizzo added that the work done with the Shared Valued Outcomes thus far has built a strong foundation on what is coming next.

Legislative Action Committee

Legislative Action Committee (LAC) Chairperson, Deborah McDermott, gave an update for the Board. The LAC committee will be holding a Legislative Night on Wednesday, January 24th @7:00 p.m. This is a unique opportunity for the community to come and speak directly to their legislators in an informal setting. She noted that Senator Marcellino is the Chairman of the Education Committee. She reviewed their goals for Legislative Night seeking ways to get good attendance, have the entire community represented and ensure that questions are answered. She further reviewed plans for how to get the community engaged in the issues and to attend the meeting. She asked the Board for any feedback or guidance. Trustee Russo suggested inviting Congressman Tom Suozzi and volunteered to reach out to him. She also suggested using the Glenwood Landing or Sea Cliff School Theatre as a more intimate setting.

Comments from the Public

Lisa Vizza, Glen Head, asked if the donation to the music tour/performance tour is a new club. Ms. Buatsi responded, it is not a club, the donation is run through the extra-curricular activity fund to offset some of the expenses associated with the tour.

Tim Madden, Sea Cliff, noted that in Dr. Giarrizzo's report he said the athletic attendance policy did not apply to the middle school, he asked if that meant it has been rescinded. Dr. Giarrizzo responded, it applies only to Junior Varsity and Varsity athletes. Mr. Madden said the policy that appears online states that it applies to middle school students as well. Dr. Giarrizzo will speak to Mr.

Lang, however he was informed by Mr. Lang that it does not apply to middle school students. Trustee Russo added, based on comments from community members, it seems the practice is applying to middle school students.
