North Shore Schools Board of Education Regular Meeting Minutes August 25, 2022

The meeting was called to order by President David Ludmar at 6:30 p.m. in the Glenwood Landing Elementary School Auditorium. Present were Trustees Colacioppo, Galati, Macari, Mosca and Russo. Trustee Cashman was absent. Also present were Superintendent Dr. Christopher Zublionis and Assistant Superintendents Dr. Carol Smyth and Mr. James Pappas.

At 6:30 p.m., on motion of Trustee Macari and seconded by Trustee Colacioppo and all in favor, the Board convened an executive session in room 101 to consider matters regarding collective negotiations pursuant to Article 14 of the Civil Service law (the Taylor Law) and proposed, pending or current litigation.

At 7:55 p.m. on motion of Trustee Galati and seconded by Trustee Mosca and all in favor, the Board came out of executive session and resumed the regular meeting in the auditorium. There were 4 people in the audience.

## **Pledge of Allegiance**

President Ludmar led the public in the pledge of allegiance.

## **Approval of Minutes**

On motion of Trustee Galati and seconded by Trustee Colacioppo and all in favor, the minutes of August 3, 2022 were approved.

#### **Report of the Superintendent**

Dr. Zublionis welcomed everyone to the start of the 2022-2023 school year. He reminded all that the first day of school is next Thursday, September 1. September 1 and 2 are half days at the elementary level and full days at the secondary level. Dr. Zublionis noted that hundreds of students participated in our summer programs, which concluded over the last few weeks. He said that both families and students seemed very pleased with these opportunities but nevertheless, as good as they currently are, we will continue to collect feedback and plan on bringing more organization and coordination to them. He remarked that this is a great example of the North Shore spirit of continuous improvement.

Dr. Zublionis reported that he was able to spend a few minutes with Coach Agovino, Mr. Lang, Mr. Pappas and the full JV and Varsity Football coaching staff and our athletes. He said he was pleased to be able to give them some words of encouragement and support, and he could clearly see the respect that they have for each other and their coaches. He is looking forward to the first home game on September 10th! All fall JV and Varsity athletes will be welcomed back next week on Monday, August 29<sup>th</sup>.

Dr. Zublionis next reported that the orientation programs for 6th and 9th graders will be held on Tuesday, August 30 at their respective schools, and Middle School Principal Dr. O'Hara will have a Meet and Greet that day at 6:00 PM.

Dr. Zublionis explained that as many may have noticed, or heard about, there is a tremendous amount of construction finishing in all of our buildings. Mr. Pappas, Mr. Hall and Dr. Zublionis have been touring the sites daily. He explained that this is the heaviest period of bond construction which will be

fully complete next summer. Schools will open on time, but some areas will not be ready for use for a couple of weeks. Our school and curriculum leaders will be working on contingency plans for the small number of classrooms impacted and work will continue after school and on weekends.

Dr. Zublionis reported that they held a great Meet and Greet event last evening at Central Office and he looks forward to the *Coffee with Chris* events on Tuesday, September 13<sup>th</sup> at 9:30 a.m. at Central Office, Thursday, October 20th, at 7 pm at Central Office, and Tuesday, November 29<sup>th</sup> at 7:00 pm in the Middle School Library. There will be additional conversations to discuss the Nassau County settlement with LIPA and the impact on the community. Finally, *Budget Bootcamps* will begin in December with several sessions planned as follows: 12/20/22 Central Office, at 9:30 am; 1/10/23 Central Office at 9:30 am; 1/24/23 MS Library at 7 pm; 2/7/23 MS Library at 7 pm.

Dr. Zublionis noted that the District has mailed out an application for three district committees (Legislative Action [LAC], Audit and the Community Budget Forum) also available on our website. Applications to join a committee are due on September 2<sup>nd</sup>. He encouraged anyone who has trouble accessing the application to email him directly.

Dr. Zublionis reported that the first Parent University meeting will be held on September 14 at 7:45 p.m. and the first Viking Community meeting will be held on September 21 at 7:00 p.m. The Viking Community meeting will be a combination of the Teaching and Learning, SEL, Equity and STEM Committees that will meet in a new structure together and then around subgroups focused on highly specific goals and topics. Since these committees often overlap in their discussions, they will alternate between subcommittee and whole group meetings. More information will be shared shortly.

Finally, all schools have received new Covid-19 guidance from New York State which is reduced from previous years and even from where we ended in the spring. Information will be communicated at the beginning of next week.

#### Regular Business District Goals 2022-2023

Dr. Zublionis provided suggestions for District Goals for the 2022-2023 school year. These include: 1) The renewed and focused commitment to the Strategic Plan (in the form of The North Shore Journey) focusing on the many different instructional efforts over the last 5-10 years, measurement of progress, reflection and refinement each year; 2) An effort to develop sustained sources of revenue and efficiency in the wake of the Nassau County Settlement with LIPA; 3) An intensive analysis of course progressions and offerings and personnel, K-12 in the wake of the need to find efficiencies but also to bring clarity, focus and depth to curricular and extra-curricular offerings.

The Board discussed potential goals. It was noted that the 5-year Strategic Plan is ending in 2023 and the "North Shore Journey" continues and strengthens the Pillars from that plan. Trustees agreed that finding efficiencies in this year's budget is very important. It was also suggested that last year's goal of community outreach and engagement be continued as it is important for residents to understand what failing a budget means to property values and to our children. It was also suggested that is put out. Including a capital reserve as a goal was suggested. As part of the discussion on course offerings, it was suggested that enrollment in IB classes be revisited and possible opportunities for students be researched to avoid small class sizes when there are limited resources. Additionally, review of the FLES program to ensure it has had the impact it was designed to, or to possibly intensify the program, as well as a review of the Middle School language program to see if there are efficiencies to find there. It was suggested to use existing committees to assist in finding efficiencies, making the CBF committee more robust and using members as ambassadors. Regarding the goal of finding sustained sources of revenue, it was suggested to investigate non-tax revenue, through legislative grants, federal & state grants specifically earmarked for K-12 schools. To advocate at the state level for how they calculate our state

aid. It was suggested the District look into a new legislative package that provides an expansion to school based Medicaid programs providing funds for mental health services for students without IEPs, as another source of revenue.

President Ludmar said he believes what needs to be a clear goal is underspending the 2022-23 budget as they will rely on fund balance this year to offset a lot of the challenges they face. He went on to say that when they crafted the budget they did not know the challenges they would be facing, and there may efficiencies that can be found or things that they must now live without. He further stated that non-tax aid from Albany has to be a goal, as well as leveraging our continued use of what has been a successful lobbying effort both locally and with the state. He agreed that advocating for a recalculation of the state aid formula is critical. Regarding the capital reserve, he said a long-term review of our infrastructure needs must mesh with the long-term spending plan, as we can't look at cutting costs without knowing what needs will present themselves. They would then need to see if that longer-term plan, with an athletic focus, would fit into a capital reserve. The community education piece, getting information out on what a capital reserve is, would be the next step. He noted that some in the community believe a capital reserve means extra spending or that it is a failure of districts to plan, when in fact it is a direct means of planning and gives districts the flexibility to fund projects needed over a course of time when funds are available. It is not the lack of planning; it is the essence planning.

Finally, focusing on some of the "smaller" goals, President Ludmar noted the way subcommittees are addressed has changed much over the years that he has been a Trustee. The Board has taken major steps toward more transparency by welcoming community members onto committees and posting documents directly onto the new platform for Board agendas. He said it is important to update those board policies regarding committees to delineate what the expectations are surrounding committee members. Regarding the recurring goal on student engagement, President Ludmar said he feels it is important to follow-up with the Tri-State work for at least one more year as student engagement is the key to both student success and wellness.

Dr. Zublionis and Dr. Smyth will look through all of the suggestions and recommendations on the goals, look for a common thread, and bring back a new draft for a second discussion on September 8<sup>th</sup>.

#### **Board Meeting Topics**

The Board discussed their meeting topics for the year. It was requested that for the September 8<sup>th</sup> meeting a second discussion on District Goals be added in addition to goals for the Legislative Action Committee (LAC). It was also requested that a discussion surrounding a possible capital reserve be added early in the fall. Dr. Zublionis will add that as a discussion item to the September 22 BOE meeting agenda. More specifics surrounding the discussion on the special education program on October 27<sup>th</sup> was requested, such as how we are assessing, identifying and providing intervention, and making sure we are using best practices. Regarding the meetings on student achievement, specifics were requested on projections surrounding curricular and extra-curricular opportunities for the athletic program, as well as the fine and performing arts program. Particularly, the dance program and the lack of committed space for that growing program. In addition, it was suggested the Board have a discussion regarding scenic design, lighting design, generally behind the scenes work for performances. Overall looking at how students interested in fine and performing arts are being educated. Dr. Zublionis will update the meeting topics schedule and disseminate it to the Board in the next update.

#### Comments from the Public - 9:00 p.m.

Lisa Vizza, Glen Head, expressed concern for the social-emotional health of students. She asked that the Board find ways to integrate health into the curriculum every year. She also noted that there should be a focus for graduate-post-graduate transitioning students.

## Old Business High School Sign - 9:20 p.m.

The Board discussed the proposed electronic sign at the high school. Dr. Zublionis explained that there is currently a mock-up sign at the site and the consensus seems to be in favor of a doublesided sign however it will need to be raised a bit higher than the current simulation. The difference in price from a single-sided sign to a double-sided sign is \$10,000. A single-sided sign would only be viewed by drivers traveling north-bound on Glen Cove Ave. The Construction Steering Committee recommends going forward with the sign. Trustee Mosca explained that she was in favor of the sign until the news about LIPA came about. Now she feels they should save the money on the sign if that is an option. Trustee Russo explained that the funds for the sign came from an allocation from fund balance and there is an expectation in the community that this project would go forward. She further explained this has been a long-term request and ties into the goal of community engagement. Trustee Macari noted that the last time the sign was brought up, the Board discussed the traffic study which did not include the pedestrian crossing. She and other Trustees expressed concern about how congested that crossing is and she wants to be sure if they proceed with the sign that it will be safe for students. President Ludmar explained that the Construction Steering Committee had decided not to invest in another traffic study as it would not yield the information on the pedestrian crossing. He went on to say much time has been spent looking and speaking about a proposed electronic sign. He feels the benefits far outweighs the cost and it is not a recurring cost. He agreed that it will increase community engagement. Mr. Pappas confirmed that if the funds are not spent on the sign the funds would go back into the general fund. Trustee Mosca asked for assurances that the county will not pull a crossing guard from that area now that they have informed the District of their lack of staff. Trustee Galati remarked that the discussion about an electronic sign has been going on for nearly 20 years. He feels if they do not go forward now it will never get done and he feels it is important to the community. There was consensus on the Board to move forward with the sign.

Trustee Mosca reported that the Legislative Action Committee (LAC) would like to get permission to have a presence at back-to-school night to hand out literature and answer questions about LIPA or other topics. The Board agreed with this proposal. Trustee Mosca also requested that LAC members receive a presentation from the District's lobbyists (DHC) to educate and assist them in advancing their goals. Trustee Mosca further requested that the interviews for the new LAC members occur as soon as possible after the September 2 deadline to possibly appoint the new members at the September 21 meeting.
