Prior to voting, Trustee Cashman asked Mr. Pappas to summarize the reason for establishing a tuition rate for non-resident students. Mr. Pappas explained that New York State sets the rate through a formula, which we can charge for tuition, however, the District has the option of setting our own rate based on the actual services being provided per student. This is the rate we charge if special education students attend one of our classes. Our policy allows only special education students to attend our schools if there is room in our enrollment.

On motion of Trustee Mosca and seconded by Trustee Cashman, and all in favor, it was: Establishment of Tuition for Non-Resident Students-Special Classes

Resolution for Appointing Impartial Hearing Officers

WHEREAS, a Board of Education is required by Section 200.5 of the Regulations of the Commissioner of Education to initiate the process for selecting an impartial hearing officer by no later than two (2) business days after receipt by the school district of a written request for hearing by a parent or guardian of a disabled student; and

WHEREAS, the Commissioner's Regulations specifically authorize a board of education to designate one or more of its members to appoint an impartial hearing officer in lieu of action by the full board in order to meet the timelines of the amended Regulations;

BE IT RESOLVED, that the President of the Board of Education, or on the occasion of his or her absence or inability, the Vice President of the Board of Education, is hereby authorized and directed

to appoint an impartial hearing officer from the District's alphabetical rotational list previously adopted by the Board of Education; and be it further

RESOLVED, that the President of the Board of Education, or on the occasion of his or her absence or inability, the Vice President of the Board of Education, shall make such appointment in accordance with the principles set forth in Section 200.5 of the Regulations of the Commissioner of Education. The District Clerk, or his or her designee, under the direction of the President of the Board, shall initiate the selection process by contacting the impartial hearing officer who last served, and shall canvass the list as provided in the Regulations until an appointment is accepted.

Regular Meeting

District Wide Safety Plan Public Hearing 8:28 pm

District-wide school safety plans and building-level emergency response plans are designed to prevent or minimize the effects of violent incidents and emergencies and to facilitate the coordination of schools and school districts with local and county resources in the event of such incidents or emergencies.

Education Law 2801-a and Commissioner's Regulation 155.17 require schools and districts to create a number of different safety teams, including the District-wide School Safety Team. The North Shore School District Safety Team, which includes representatives of the school board, staff, faculty, administrators and parents, has the responsibility of reviewing and updating as necessary the district's safety plan on an annual basis.

The District is required to hold a public hearing that provides for school personnel, students, and public participation, and must be made available for public comment at least 30 days prior to the hearing.

The North Shore School District's Safety Team reviewed and updated the DW Safety Plan at their May 14, 2025 District-wide safety meeting.

The 30 day "Notice of Public Hearing" was published in the local newspapers on June 5, 2025. The DW Safety Plan was made available for review by the public on the district webpage and at Central Office.

President Macari opened the floor for questions or comments on the District Wide Safety Plan. With no comments, President Macari closed the public hearing.

Prior to voting, Trustee Mosca noted that, although she did not serve on the committee this year, she has served on it in past years. She said the process the committee goes through to produce this document is excellent, well run and thorough. She commended the Director of Facilities, who heads the committee, for a great job.

Report of the Superintendent

Dr. Zublionis welcomed all to a new fiscal year. He thanked all of the principals and PTOs for making graduation and moving on ceremonies so special this year. With special note was the "grad walk" when graduating seniors walk through their elementary schools. He was especially moved by the student speeches. Dr. Zublionis explained that the summer will be very active with the TENS program, enrichment program, and ESY program running already. They are actively hiring new Vikings; Mr. Chris Marino, Special Education Director is moving on from the district after 15 years and a search for a new director is underway. Committee interviews with parents, administrators, and teachers will take place soon. Dr. Zublionis thanked Mr. Marino for all he has done for North Shore and wished him well. The district is implementing a new community message platform and Dr. Zublionis thanked Mr. Kaye for applying it so quickly. Dr. Zublionis is working with our architects on projects for a potential bond vote in late fall; communications about this will begin to be sent out in early fall. Dr. Zublionis thanked the custodial and maintenance staff for all the work they have been doing to already get the schools in shape for September. He reported that the first day of the Administrative Retreat was energizing and he thanked the Board for their support. Finally, Dr. Zublionis reviewed important dates over the summer ending with new teacher orientation the last week of August and Superintendent's Conference Day on August 27.

Trustee Cashman noted there is a growing population of ENL families in the District and she would therefore like to ensure we are reaching everyone we need to reach, providing necessary resources and meeting their social, emotional needs.

Dr. Zublionis explained that he is working on the mandated device policy put in place by the state. He will try and convene a meeting of the Policy Committee and bring a draft to the Board.
