

North Shore Welcomes Its New Pre-K Program

On February 1st, 2023, history was made as a Pre-K program was added by the North Shore School District. This addition had been talked about in the past, but it finally came to fruition at the end of the 2022-23 school year. The District was given a special UPK (Universal Pre-K) expansion grant from New York State, which contained the funds needed to start the program. The State allowed the District to spend 5,400 dollars per student in the Pre-K program, which will be a very valuable resource for parents in the District, as private Pre-K education could cost 8,000 dollars or more per year, plus the District's school fees they are already paying.

The Pre-K program consists of three classes, two of them are held at District elementary schools such as Sea Cliff School (SCS) and Glen Head School (GHS), and the third is held at the Glen Cove YMCA. The majority of the seats are filled in the program, as each class has about 14-18 students in it. Since the YMCA already had a Pre-K program in place, the children's days would function similarly to the other

SCS and GHS however, students begin a little later than the other elementary students at 9 am and end earlier at 2 pm to avoid the busy pick-up and drop-off times. A typical day functions almost as a kindergarten class would with a morning meeting, activities, lunch, and snack breaks. The curriculum is just a simpler version of kindergarten as it incorporates more basic skills. There are two certified teachers per class working with these students. These teachers are provided by an organization called SCOPE Education Services. This organization offers many services to school districts in New York State. It had all of the resources needed to begin the Pre-K program and use the District's space to educate the young students.

Despite support from SCOPE, the North Shore School District faced certain challenges as the program was being created. Since the addition came halfway through the year, all of the classrooms at the elementary schools were already in use. This meant that certain sacrifices had to be made to find space for the new Pre-K classes. The classes that are held in that space. At Mandarin room at SCS, as well as the

faculty space at GHS, were therefore converted into the new Pre-K rooms. Dr. Christopher Zublionus the Superintendent of Schools for the North Shore School District, said that, "the teachers were amazing in their flexibility." Though the program began halfway through the school year, next year, the program is expected to begin normally in September. Looking to the future, Zublionis says, he thinks that the District "will expand and work with more pre-schools [while continuing] to work with the YMCA." This would create more classes and opportunities for kids and parents in the District.

Parents should quickly take advantage of this new addition as it could become quite popular. In order to get into the 2023-24 school year program, there was a lottery that took place in April. Parents entered this lottery so that their children would have a chance at receiving a roster spot in one of these District classrooms. Since there are a limited number of spots, in future years this lottery could become increasingly harder to "win". Lori Ruderman, a parent of a current Pre-K student at

Sea Cliff Elementary, is thrilled with the new opportunity. "We would highly recommend this program. Very quickly Phoebe [her daughter] transitioned into this new caring and loving environment. Developmentally she is ready for kindergarten, but she is still being given the opportunity to learn play skills and make friends." This preview into the kindergarten environment clearly prepares students for their upcoming years in elementary school. Ms. Ruderman added that, "Phoebe is doing amazingly well in this program. Sometimes she comes home with paint on her, or stickers, or an amazing hat she made to learn the letter of the day. To us that is the best sign of her growth and happiness in the program."

Overall, the teachers and the environment in the Pre-K classroom were clearly well thought out. The students are happy and excited to continue their learning experience, which is important for their motivational level. As the youngest Vikings continue to grow in the new program, it is obvous that North Shore's new Pre-K program is quite a success.

the city. Masten Martin said, "I would just want to spend more time there." Doing something like this would make the Spain trip more similar to others like the Italian exchange trip where the American students leave the families they stay with to see other parts of the country for a couple of days. Another change that was mentioned that the organizers could consider making was suggested by Masten Martin. "Maybe they could ask if there are any places we want to go to and just go there". To do this, there could be a meeting held before the trip where students get to suggest places they would like to visit; the organizers could then consider those thoughts or express to them why they would not be feasible.

Finally, regarding staying with a host family while on the trip, Cash Evans stated, "I preferred staying with the students. It made me feel more integrated into the culture and made my experience feel much more authentic. I also spoke the most Spanish while I was at the house, so that helped me improve and practice." By the end of the trip, the group had grown together and became a close-knit family of sorts; and, I think I can speak for all when I say that this travel opportunity was an experience of a lifetime that we could never trade.



College is one of the most vital experiences one can have. While it is by no means necessary in order to live a fulfilling life, it is still incredibly useful. At its core, college manages to build both the knowledge and skills needed to succeed; some of these include broad outlooks, organizational ability, deadline accountability, knowledge of a field, and professional skills learned from a person's veteran professors (Bouchrika). The importance of these skills is reflected in the data of college graduates as they are significantly financially better off than those with a high school diploma or an Associate degree. While the median weekly incomes of high school graduates and those with an Associate degrees are \$809 and \$963 respectively, those with a Bachelor's degree earn \$1,334 (Bureau of Labor Statistics). This leads to greater financial stability and wealth accumulation as those with higher incomes can invest any spare income. Additionally, over a lifetime, a college degree is worth 2.8 million dollars (Merisotis). Similarly, those with a college degree have a far lower unemployment rate at 3.5% as opposed to 6.2% and 4.6% for those with a high school diploma and Associate degree.

Yet, these numerous occupational and financial virtues have recently been unable to attract students' attention. In recent times, undergraduate enrollment has slumped with every passing year since 2017 seeing a decrease. In 2017, about seventeen million undergraduates enrolled in the fall. But in 2022, there were just fifteen million (National Student Clearinghouse). This precipitous drop of about 12% is not primarily caused by Covid-19 either as the trend started before Covid-19 and continues even now. However, while Covid-19 may not have caused this trend, it did exacerbate the actual cause: the cost of college. With Covid-19 causing economic damage and spurring subsequent inflation, many people's finances have worsened, and college appears to be more out of reach than ever. But if the primary barrier is cost, then surely lowering the cost would increase enrollment.

Unfortunately though, lowering college expenses is easier said than done. At first, it may seem that simply cutting costs could lower college expenses given that the United States spends the second most per student in the world. However, most of that cost is from paying faculty and staff (Ripley). Thus, even if we cut out many of the superfluous expenses, our costs remain high and our appealing college amenities would be gone. This is further complicated by our byzantine three-pronged approach to colleges as students face vastly different tuition costs, with those at public institutions facing average tuition costs of \$9,400. private nonprofits facing \$37,600, and private for-profits facing \$18,200 (National Center for Education Statistics). These students face

different circumstances, and their colleges have different programs, meaning that attempts at cost-cutting measures across the board would be logistically impossible to implement. In its stead, one may suggest as a solution direct aid to students. But since an average of \$15,330 of student aid is given to students already, how much more should it be (College Board Research)? Allowing blanket aid would be exorbitantly expensive, no matter what form it takes. Additionally, blanket aid would not assist those who truly need it as the main beneficiaries of such aid are those with higher education and incomes (Looney). As one attempts to tackle the problem of costs, they uncover the convoluted nature of our colleges.

To reinvigorate college enrollment and lower its cost to students, we must untangle its byzantine nature. We could implement this through the publication and spread of a list of low-financial-value programs (Meyer). This list, if it were properly created and distributed, could lead to a large portion of future students choosing good careers and paying off their student loans; after all, most people with student loans have less than \$20,000 (College Board Research). This list of low financial value programs would lead to greater transparency and, while it may not end the byzantine status of our colleges, it could guide future students through a winding path and prevent them from suffering from student debt for most of their lives. While this could guide future students, we must also help those who are already beleaguered by student loans. A helpful reform for these people is to treat educational loans like consumer debt and allow them to be discharged via bankruptcy. This would help those in need and prevent student loans from further burdening these people.

These administrative reforms may assist people greatly, but we must also simultaneously work to make college more favorable and accessible cost-wise. As mentioned earlier, the costs of college are largely required as the faculty is vital and cannot be removed. However, the cost for students can still be reduced in several ways without drastically altering the college experience. The number of nonteaching staff could be cut, allowing for resources to be dedicated elsewhere or removed from the cost entirely (Council on Foreign Relations). Another solution involves restricting federal loans for students at institutions with poor student outcomes, which discourages future students from obtaining an ineffectual education (Council on Foreign Relations). This, in turn, leads to the shrinking of problematic institutions and the promotion of better institutions and educations. Lastly, college costs could be lowered through government intervention. This would help colleges and students the most directly, but it would also be more expensive than the previously

mentioned cost-cutting measures. However, one must keep in mind that the subsidization of education through funding colleges and giving aid to students who need it leads to a more robust educational system (Council on Foreign Relations). It is by no means a senseless expense and could prove to be a boon as future citizens earn better educations at less burdening costs.

While colleges and the reforms needed to fix them can seem byzantine, it is important to stress how imperative these institutions are. The benefits are not merely financial and can extend into many matters of one's life. To ensure that more people, rather than fewer people every year, obtain these vital experiences, aid and systemic reforms must be implemented. In a time when many people are plagued by college debts and apathy for colleges is growing, the college system must be revitalized and reformed through untangling byzantine systems, removing some non-essential staff, and offering greater state subsidization of colleges via selective funding and aid.

To Be Woke Or Not To Be Woke: A Dive Into The Political Buzzword

Before 2014 the word "woke" was rarely used, and certainly never uttered in political spaces, let alone in Republican presidential debates. In 2023, the use of "wokeness" or "woke" in primary debates seems almost guaranteed; however, many users of the political buzzword have little to no idea what it means and where it originated from.

In the Merriam-Webster Dictionary, the term is defined as "well informed or aware, especially in a political or cultural sense". The term gained popularity at the start of the Black Lives Matter movement in 2014, but was only included in the Oxford Dictionary in 2017 due to a rapid increase in mainstream usage, especially in politics. Currently, the term is closely associated with the "New Left", a political stance that advocates for cultural and social issues like race, sex, and gender equality (Cohn).

The "New Left" emerged with President Obama as he brought in a focus on racial inequality, and gender inequality, as well as protecting the LBGT community from hate. The New Left believes that racism, sexism, and other oppressive hierarchies are deeply embedded in American society, and supports academic theories such as critical race theory. Despite the dictionary definition of the term "woke", many categorize the term as someone addressing these "New Left" issues such as "critical race theory, non-binary pronouns, trans rights and the fate of university courses"(Cohn).

However, this term has become a word more commonly used by Republican politicians wishing to insult the liberal party and its viewpoints during rallies or presidential primary debates. President Donald Trump and Florida Governor Ron DeSantis have been at the forefront of this term in recent political debates. DeSantis claimed during a speech this past April, "We will never surrender to the woke agenda!" Many have questioned DeSantis and Trump, trying to understand exactly what they mean by the "woke agenda". The DeSantis Administration responded by defining "woke" as "the belief there are systemic injustices in American society and the need to address them". However, when asked to define the term, conservative writer Bethany Mandel became the subject of considerable ridicule on social media as she was unable to concisely define the term in an interview. Therefore, although DeSantis has defined the term, it seems rather elusive to the Republican party as a whole.

The reason "woke" has become such a buzzword for Republicans to throw around almost as if it was a slur is because it sums up everything the Republican party stands against. This term seems to encapsulate everything the

become a regular part of teenage life, as at least one social media app can be found on most teenagers' phones ages 13-17 (aacap.org). On average, these teens spend around nine hours online per day, endlessly scrolling through short, dopamine-inducing content (aacap.org). This continuous scrolling and borderline addiction does in fact take a toll on these young, still-forming minds.

One social media app in particular has grown rapidly in popularity ever since the quarantine; that app is Tik Tok. In 2022, TikTok was the most downloaded mobile app worldwide (statista.com), and for a good reason. TikTok is a social media app that consists of seemingly

right wing opposes: social justice issues, granting rights to those minorities like LGBTQ, and trans people, and solving the climate crisis. DeSantis claims that "What you see now with the rise of this woke ideology is an attempt to really delegitimize our history and to delegitimize our institutions, and I view the wokeness as a form of cultural Marxism". Overall, the GOP feels that such stances are "liberal excess", and is using its political power to fight against it.

Over the course of their time in power, the two leaders of the "anti-woke" movement claim that in the future they will do everything in their power to remove liberal legislation (Muddle). Donald Trump and Mr. DeSantis swear to pass federal laws recognizing only two genders and punish doctors who provide gender-affirming care for minors. In addition, DeSantis says that he would ban gender studies, and has recently passed the "Stop W.O.K.E. bill" last April which "essentially prohibits instruction on race relations or diversity that imply a person's status as either privileged or oppressed is necessarily determined by his or her race, color, national origin, or sex" (Florida Senate).

However, "wokeness" as a buzzword has just been another way our country has fallen into further political polarization. In the past 10 years, particularly since the election of Donald Trump, our political sphere has grown farther and farther apart on almost all stances. For liberals or more left-leaning individuals, the term has a positive connotation, relating much closer to the original definition of "well-informed". As a professor of political science and African American studies from Penn State explained, "When people talk about being woke or becoming woke, they're talking about being wellinformed and well-aware of systemic oppression and injustice." On the contrary, the Republican party drives the narrative that "wokeness" is a movement dedicated to undermining the institutions America was founded on and promotes citizens to stray from traditional conservative values.

Therefore, as the word itself takes on two different meanings in American society, so does our view of what America should be. On the one hand, the left believes our society should strive for change and progress into a place that has no inequality. On the other hand, the right exclaims that our country should protect its traditional values, even if it means "recognizing systematic injustices" (DeSantis). It seems that as time goes on the parties are growing further and further apart, and "wokeness", although just a word, has nonetheless contributed to it.

OPINIONS 5 The RESTRICT Act: A Trojan Horse For Censorship **By: Séamus Hughes**

Since the presidency of Donald Trump, there have been talks of banning TikTok, the popular Chinese-owned video platform. According to TikTok, the app is used by more than 150 million Americans, accounting for nearly 50% of the country's total population. The bipartisan RESTRICT Act, which was recently introduced to Congress, has implications far beyond banning an app that lets people watch silly videos. The bill has been touted as a way to protect the United States from the threat of foreign espionage and cyberattacks, but the push-back has pointed out how this Act not only stifles free trade, but also directly violates the First Amendment by giving the government full power of censorship.

In August of 2020, former President Donald Trump signed Executive Order 13942, with the goal of banning TikTok, alongside a similar order against Chinese-owned messaging app WeChat. ByteDance, the owner of TikTok, announced that it was willing to sell the U.S.'s TikTok operations, an action that wouldn't make sense if they needed to collect data on Americans. While these bans never went into effect, the same ideas still remain. While President Joe Biden overturned these bans with Executive Order 14034, the anti-TikTok sentiment remained. On December 30, 2022, Biden approved the No TikTok on Government Devices Act. In March, Senator Josh Hawley introduced the RESTRICT Act, which allows the government to ban apps from several countries, including China, if they are perceived as threatening. Although it does not mention TikTok by name, this bill has been seen as another attempt at banning it.

Despite operating under the guise of protecting user privacy, the RESTRICT Act does no such thing. Instead, it paints over international businesses in broad strokes that allow for the government to easily perform censorship. While there are legitimate concerns over the data TikTok collects, as with any other social media company, we should be concerned whether this data ends up in the hands of the Chinese government or an American corporation. What we need is a "comprehensive policy that starts closing the gaps," according to Senate Finance Committee Chairman Ron Wyden. We need an actual solution that doesn't just point fingers at China for our carelessness with our data. The Electronic Frontier Foundation (EFF) argued that "this bill is a distraction from real progress on

privacy." As a solution, it proposed more general privacy-protection legislation, which would protect the consumer, unlike the RESTRICT Act.

The censorship potential of this bill however, is insanely draconian. The vague language, according to Rae Hodge, threatens civil liberties and First Amendment rights. Hodge also points out an issue with the lack of oversight over the decision to ban apps. Additionally, it is unclear whether or not the use of a VPN to circumvent the ban would be allowed. but if it is not extreme, government surveillance would be required to stop it. This violation of free speech is insanely regressionary, and would only sharpen the divide between the United States and China.

Ultimately, TikTok's handling of data is a severe issue, just like it is on practically any social media platform. While there are legitimate concerns about this data ending up in foreign hands, more sweeping data protection would do so much more for consumers than the RESTRICT Act. What the proposers of this bill want is not to protect our privacy, but further anti-Chinese fear-mongering and allow for censorship. The issues with this bill are so clear that Tucker Carlson agreed with Alexandria Ocasio-Cortez's opposition to it (Hodge). While TikTok users may find this bill stupid or annoying, and others may find it harmless, the RESTRICT Act sets up the unacceptable ability for the government to censor, and it must be stopped.

Social Media Sustains Consumerism

Since the 1950s, America has been known for being a consumerist society. With the creation of the internet, it has become easier for people to obtain any goods through online shopping. This method of shopping also allows people to buy things more frivolously due to its convenience; also, the fact that the shopper is constantly bombarded with ads does not hurt either. The biggest propoenent to this cause is the rise of social media, as more consumers are being influenced by it everyday.

In just a few years, the social media platform TikTok has exponentially grown in popularity. With over 150 million Americans on the app, people are exposed to all kinds of content all day everyday. While scrolling through their feed, users may see unboxings, shopping hauls, and "get ready with me" videos. These videos are made by varying accounts and can be used to push different products on users. Sometimes, the use of a certain product in these videos can be enough to convince the users to purchase it. Oftentimes, the more popular the creator, the more influential she is, and the more likely she is to sell out a product. For example, Alix Earle is a creator who get this done. Through her TikToks, she has caused an array of products to sell out, including Mielle hair oil, multiple shades of Rare Beauty's liquid blush, the Tweezerman eyelash curler, the Retrofête alphabet earrings, and Charlotte Tilbury's contour wand (Rey). This can make it extremely difficult for those who previously enjoyed the product to obtain it again, as loyal customers are being replaced by newly influenced social media users. Despite this downside, having this type of media coverage benefits the brand in such a huge way. To take advantage of a creator's influence on TikTok, companies often send her a PR (public relations) package. In response to receiving the PR package, the creator will make a TikTok video promoting the product. This gives the company a new way to advertise to an even wider audience, at little to no cost. When a consumer sees an influencer she admires promoting a product, it gives the product more appeal.

With new items being displayed to audiences every day on social media, new trends arise as well. When a new trend appears, consumers automatically want to join in with the trend and fit in with everyone else, so become more likely to purchase this product. But by the time the consumer receives the product, often, a new trend has started, and then another purchase is made. In the article "Perpetuating Consumerism: The Role of Social Media and Self-Image," the author states that "when trends come and go, it can be tasking on our self-image. It's difficult to fit in when what is 'in' is always changing. It can lead to a sense of isolation, or the idea that we're missing out" (Burrows). The sense that one is not perceived as 'cool' because she does not have a certain trending product is an even bigger motivator for a person to make impulse purchases on something trendy. As a result, consumers become the 'proud' owners of an abundance of items that were once considered "trendy".

With daily exposure to influencers, it is easy to fall into the trap of 'the trend cycle'. However, some creators on TikTok are trying to stop the process of overconsumption that stems from the app. This is done in a method called "deinfluencing." One article describes this as "a term that's been recently invented by creators who are urging viewers not to buy something, or calling criticism to cult-favorite products" (Chen). This is done by influencers who are not considered brand ambassadors. They give an unbiased review of a product that a different creator was paid to promote. This can cause users to second-guess their favorite trendsetters by thinking for themselves to see if a product is really worth buying. Coupled with this tactic, creators are also beginning to show their followers less expensive replacement products for high end cosmetics; these are known on the internet as "dupes". While finding cheaper alternatives for products can be beneficial to consumers who may not be able to afford more expensive products, this can hurt the companies that created the original product. However, deinfluencing does not one-hundred percent solve the problem. When a popular creator tells consumers not to purchase a product, she often gives them a different one to buy instead, therefore still influencing her audience to continue the cycle of consumerism.

Overall, the spread of consumerism cannot easily be tamed. The cycle is fed by social media platforms that are supported by and therefore filled with ads. The solution to this problem is unclear. But, with the consumer at the root of the issue, a change in behavior could be what is needed.

Risks And Rewards: The Approval Of The Willow Project

The Willow Project, a proposed oil and gas development project located in the National Petroleum Reserve-Alaska (NPR-A), has been a controversial topic for years. Recently, President Joe Biden approved the project's environmental review, allowing it to move forward. This decision has sparked concerns among environmentalists and indigenous communities who fear its the potential repercussions. The Willow Project was proposed by ConocoPhillips, an American multinational corporation engaged in hydrocarbon exploration and production. It is an \$8 billion plan that involves extracting approximately 600 million barrels of oil and 3.4 trillion cubic feet of natural gas reserves from the NPR-A. The project includes the construction of a drilling site, pipelines, and other necessary infrastructure that will help in the extraction of the resources.

Proponents of the Willow Project argue that it will create jobs and boost the economy. According to an article written by Eric Revell that was published on March 15th, 2023 for Fox Business, the Willow Project is predicted to generate between \$8 billion and \$17 billion in new tax revenue for federal, state and local governments. In addition, according to the Bureau of Land Management, there is a possibility that "the Willow Project could create more than 2,000 construction jobs and 300 permanent jobs" ("Support for Willow Project Development"). However, opponents argue that it will harm the environment and indigenous communities. One of the primary apprehensions surrounding the Willow Project is its potential impact on the environment. The NPR-A is home to a diverse array of wildlife, including caribou, polar bears, and migratory birds. The project could disrupt their habitats and lead to the destruction of their ecosystems.

The drilling and construction activities associated with the Willow Project could also lead to increased greenhouse gas emissions, thus, contributing to climate change. Critics argue that the project's contribution to climate change will exacerbate the already existing environmental crisis and harm the planet's natural systems. With this being said, the approval of this project has shocked the nation, as many people are bewildered as to how the Biden administration could have come to this decision. Knowing that this project will likely have severe consequences on the environment and our future, individuals are protesting against this decision of the government and speaking out on the impacts. According to the Natural Resources Defense Council, "the Biden administration acknowledges that Willow, if completed, would release an additional 9.2 million metric tons of carbon pollution into the atmosphere each year...("Why the Willow Project is a Bad Idea"). However, just recently, Biden publicly stated his intentions of reducing carbonpollution in the next decade or so: "President Biden has set an ambitious

U.S. goal of achieving a carbon pollution-free power sector by 2035 and net zero emissions economy by no later than 2050" ("FACT SHEET: President Biden to Catalyze Global Climate Action through the Major Economies Forum on Energy and Climate"). The Willow Project's approval remains a controversial topic, and has recently raised a myriad of questions about the Biden administration's commitment to climate change, especially when considering the President's pledge to transition to a clean energy economy.

Despite these concerns, the Biden administration's approval of the Willow Project hopefully means that it will be subject to environmental regulations and mitigation measures to minimize its impact. The project will be required to follow strict guidelines such as requiring the use of advanced drilling technologies, the use of insulated pipelines to reduce the risk of oil spills, and the implementation of wildlife protection measures. Additionally, the government has committed iself to reducing its greenhouse gas emissions associated with the Willow Project by 50-52% by 2030. ("What Is the Willow Project? ConocoPhillips' Disastrous Plan to Drill in the Western Arctic"). ConocoPhillips has also pledged to work with local communities, including the Inupiaq people, to address its apprehensions and provide economic opportunities. The creation of jobs and an investment in the local economy have been discussed.

Even though some positives could potentially come from the Willow Project, many environmentalists and indigenous communities remain skeptical of its possible consequences. They argue that the project's approval undermines the Biden administration's climate change agenda and sets a dangerous precedent for future oil and gas development in sensitive environments. The Willow Project is a contentious issue, that has arguments both for and against it. While it is true that the project could provide economic benefits and jobs, it also poses significant risks to the environment and indigenous communities. The Biden administration's approval of the project has raised concerns about the administration's commitment to climate change and environmental protection. It remains to be seen how the project will impact the region and whether its benefits will outweigh its costs.

Overall though, as the world faces a looming climate crisis, it is crucial that we prioritize the protection of our environment and the rights of communities.

(Continued From Page 6) influencer named Douglas Mackey tweeted a joke during the 2016 election that read, "Avoid the line. Vote from home. Text 'Hillary'

to 59925." This act by Mackey landed him 10 years behind bars with critics saying he "used Twitter to disseminate false information to redirect would-be voters of Hillary Clinton in the 2016 presidential election" (Washington Post). Jokes earn people jail time, but willingly covering up a true news story to help a candidate win an election is something to look away from.

Unfortunately, it doesn't stop there. The Department of Justice never fails to demonstrate colluded behavior. On August 10th of 2019, Jeffery Epstein, who faced sex trafficking charges, was found dead in his jail cell. Ever since then, the media has said that Epstein killed himself and that anyone who dares to think otherwise is a conspiracy theorist. However, initially the story made so little sense that even failed New York City Mayor Bill de Blasio said, "The facts themselves don't make sense on their face." In a speech given by then Attorney General Bill Barr shortly after Epstien's death, Barr said, "We will get to the bottom of what happened and there will be accountability." Despite this remark, almost four years later, many reasonable thinking people still have questions about what exactly happened. Moreover, the two guards who "shopped online, took breaks, and napped" (New York Post) on the night of Epstien's death pleaded guilty to falsifying government records. However, last year, an Obama appointed judge, Analisa Torres, dropped the charges against the two for no apparent reason. When Bill Barr declared the Epstein case closed, he cited that "the New York City medical examiner had conducted an autopsy and ruled that Epstien killed himself by hanging," and "I personally reviewed that video footage; it shows conclusively that between the time Epstein was locked in his cell, at 7:49 p.m. on the night of August 9 and the time he was discovered the next morning at 6:30 a.m., no one entered his tier." This was enough information for Barr and much of the media to say that Jeffery Epstein killed himself. However, many critical thinkers began to question statements being made and didn't just eat up what the media had to say. For example, Barr starts by saying the autopsy conducted concluded that Epstein hanged himself. But, Michael Baden, a pathologist, said, "The forensic evidence released so far, including autopsy, point much more to murder and strangulation than the suicide and suicidal hanging." Baden also said that it was "very unusual" that the initial cause of death following the autopsy was pending, but then changed to hanging. Why would that happen, especially since no new evidence was released. Moreover, Barr also claimed to review the video footage from that night. It just so happened that the cameras that were focused on Epstein's cell were not working, so Barr had to review the footage from cameras that were focused on the entrance to the tier, which is what Barr said no one entered. Alright, no one entered Epstein's cell block, but who said the murderer had to have been from the outside. There were seven other cells located within the tier, each holding dangerous criminals. Nevertheless, this idea never presented itself to Bill Barr. There are many unanswered questions such as were inmates within the cell block able to move from cell to cell? Why are there no pictures of Jeffery Epstien dead in his cell hanging? Additionally, Epstein frequently socialized with many high-profile people including Bill Clinton, Donald Trump, vaccine expert Bill Gates, and many more (NPR). After Epstein's death, none of these people seemed to care. In an interview with PBS, Bill Gates, while smiling, said, "Well, he's dead. So in general you always have to be careful." Perhaps none of these people want to talk about Jeffery Epstein because when he died, so did all of the secrets they shared. Sadly, some of it doesn't make much sense. By no means was Jeffery Epstein a good person. However, people don't deserve to live in a country where a corrupt government agency can potentially cover up a killing of a certain person and get away with it.

You see the dancing videos, cooking videos, vlogs and a user cooking chicken and mixing it with NyQuil, the over-the-counter cough medicine. Yes, you read that right. Nowadays, many users on social media are taking part in dangerous trends on TikTok. They have become blind to the dangers of social trends due to their young age and lack of brain development.

Over the past few years, TikTok has grown in popularity. According to NBC News, in March 2023 there were about 100 million people in the US that regularly use TikTok. This app has become appealing to all age groups. Although TikTok has spread positivity regarding awareness in regards to mental health, it has also caused damage. (The New York Times). She adopted her dog when he was just four weeks old, and did not anticipate the hefty food expenses, vet expenses, and since returning to work, the daycare expenses. These issues seemed to be present with many other first-time pet owners throughout the pandemic. Immediately after the pandemic

appeared to die down, shelters started to receive the pandemic pets. Many people did not want to give up their pet to a shelter; however, they felt the need to do so due to the lack of necessary and proper care that they could not provide for their pet. A nokill animal shelter in New York reportedly received over 650 surrendered guinea pigs in 2022, which is over a 300% increase from previous years (The Guardian). Phones, computers, cars, tv's, home appliances, and military weaponry; practically every piece of technology that utilizes energy, is run by microchips or computer chips. There are two main categories of these chips: logic and memory chips. The logic chip's job, simply put, is to execute a task. And, just like the name suggests, memory chips store information. If there was a halt in the development of these chips, an industry worth over 500 billion dollars would stop functioning, nearly all electronics would cease to be produced, and technology as we know it, could stop advancing until a new way of manufacturing it is found. This claim was substantiated during the COVID-19 pandemic as the microchip shortage caused a halt in the supply chain of cars, which in turn forced prices to skyrocket. Three years later the entire market is being threatened. But why?

During the 1960's when microchips were first produced, they were mostly used for missiles and other military weaponry; however, American corporations, such as Intel, realized their profits could increase exponentially if the market expanded to include civilian use. In order for this to happen, the chips needed to be manufactured cheaply and at a more efficient rate. Thus, the U.S. began moving its factories to Taiwan, Japan, and Korea, each U.S.'s allies with affordable, available labor; in addition, China and Russia, both U.S. rivals, were blocked from using these territories and prevented the development of their technology. Since these countries gained access to advanced chips, Taiwan, and the other countries were advancing at nearly the same rate as the U.S. However each of the new corporations was not self-sufficient in its partnerships with the U.S.; the corporations were being supplied with the latest machinery that was only manufactured in the Netherlands. However, these machines needed equipment from the United States to function, which meant the market was being stretched throughout the three most prevalent continents. This brings us to the main problem here: China. Throughout the development of the market, China had yet to catch up in its development of microchips and its yearning to compete with the U.S. when it came to levels of advancement; the U.S. however, needs to be the pinnacle of technology, and in order for China to manufacture U.S. level advanced chips, it needs the U.S, and clearly that isn't an option. China aims to be completely isolated and self-sufficient in the microchip market. Eventually the Chinese government will need to invest gargantuan amounts of capital in its own manufacturing companies, just to

In today's polarized political discourse, few names have gained such infamy as that of Florida's governor Ron DeSantis. Nowadays, it seems that every week we see some headline about how Florida, which, as DeSantis proclaimed it, is "the freest state in these United States." However, lately it seems as if DeSantis is trying to restrict the freedom of the LGBTQ+ community or ranting about how "Florida is the place where woke goes to die" (Vakil). Touted as the most prominent rival Donald Trump will potentially face in the 2024 Republican Election, to say DeSantis has built a reputation as a controversial figure is an understatement. kickstart the microchip market within China. However, China is still generations behind in technology.

In 2018, a trial involving ASML, the largest tech supplier of the microchip industry, accused two Chinese tech companies, Dongfang Jingyuan Electron and Xtal, of being the same company that were connected to the Chinese government. It turns out that these companies were the same in that they were created a month apart in 2014 by a former engineer of ASML, Zongchang Yu. One year later in 2015, Yu fled to China. It was revealed that the motive was to obtain ASML technology and use it in China to catch up to the U.S. After this conflict, Donald Trump, the United States' president at the time, banned U.S. companies from selling components to ZTE, a major corporation and then later, Huawei, China's most prolific tech company. These bans were further enforced after Joe Biden was elected to office. In 2022, Biden's policy prevented all U.S. companies from selling chips to China. The policy also stopped Chinese companies from using U.S designed software and equipment. The final blow banned global companies that use advanced microchips from selling these chips to China. Later in the year, the U.S. made a deal with the Taiwanese company TSMC to develop factories within the U.S. to once again gain the upper hand, but also to prevent China from having access to all of the U.S.'s manufacturing plants.

Taiwan is home to the largest manufacturers of microchips in the world; even a portion of China's chips are manufactured there. Taiwan is roughly 100 miles off the coast of China and China's failed attempts to steal U.S. technology, in addition to the tech rivalry, puts Taiwan in a dangerous position. However, the Taiwan Relations Act states, "the United States shall make available to Taiwan such defense articles and defense services in such quantity as may be necessary to enable Taiwan to maintain a sufficient self-defense capacity as determined by the President and the Congress". The Act puts the U.S. in a tough position; if China does invade, the U.S. is forced to respond, with the battle ground being the country that is home to the world's most prolific tech manufacturing plants. The war would have catastrophic consequences and would likely collapse the global economy. So, hopefully, in time, things will calm down and the microchip issue will no longer be an issue.

When Success And Power Don't Help

Alex Murdaugh, a once prominent South Carolina attorney, and a member of one of the most powerful families in that state was recently tried, and found guilty on all counts in the murders of his wife and son. The Murdaugh family had built for itself an image of success and power via the creation of an empire of a law firm. The name that once summoned sentiments of power, money, and legacy, now drags with it the mention of murder, theft, and lies.

The murders of Maggie and Paul Murdaugh had been unsolved without any suspect for over a year. Then, on July 14, 2022, "Alex Murdaugh, was indicted on two counts of murder, with the authorities saying he fatally shot his wife with a rifle and his son with a shotgun" (Bogel-Burroughs). The prosecution's case was based on the belief that Murdaugh killed his wife and son in a failed attempt to hide the financial crimes he had committed; Murdaugh has allegedly stolen millions of dollars from his clients and law firm, and had been in prison for some of these crimes since October 2021.

Murdaugh pleaded not-guilty, as he "insisted he did not kill his wife and son" (Chappell and Bowman). Still, at the conclusion of the trial, the jury unanimously agreed that Alex Murdaugh was guilty on all counts. He was sentenced to life in prison.

Judge Clifton Newman, who presided over this trial, said that the evidence that Murdaugh is guilty was "overwhelming". Furthermore he denied the defense's request to declare a mistrial.

This case was however, presented with a lack of physical evidence. Furthermore, the only eyewitnesses to the crime were killed, those being Maggie and Paul Murdaugh. According to an NPR article by Bill Chappell and Emma Bowman, "Prosecutors built a case against Murdaugh using circumstantial evidence, lacking eyewitnesses, video records or a murder weapon". Even with a lack of physical evidence, or eyewitness accounts, the fate of Alex Murdaugh was agreed upon by all members of the jury.

After the verdict of this trial was delivered, Prosecutor Creighton Waters said, "Justice was done today, it doesn't matter who your family is. It doesn't matter how much money you have or people think you have. It doesn't matter how prominent you think you are. If you do wrong, if you break the law, if you murder, then justice will be done in South Carolina." Even though Alex Murdaugh came from a high-powered family in South Carolina, the wrongs he committed during his lifetime eventually caught up with him. He is now facing the consequences of his actions that he thought would happen because of the family he is associated with.

Glen Cove 101

Most people who attend the North Shore Schools, think only of Sea Cliff, Glen Head, and Glenwood Landing being a part of that District. However, many students who attend North Shore live in Glen Cove. So why not share a little history about it?

In 1668, a man by the name of Joseph Carpenter bought 2,000 acres from the Mattinecock Indians. He and five others named that land Musketa Cove and they built a gristmill and a saw mill near the water, as Glen Cove is surrounded by it on three sides. This way, the harbor or Sound could be used to ship goods and lumber to New York City.

Then, in the 1800's, Thomas Garvie found a lot of clay deposits on his land; this land is now called Garvie's Point. As a result, the clay was dug up and sold in New York City to be used for different types of goods. Due to the industry that could then be found in Glen Cove, by 1829, there was a steamboat that ran daily from Glen Cove to New York City.

Unfortunately, a lot of people from New York City did not want to visit Glen Cove because Musketa sounded like mosquito to them. That's when, in 1834, the name was changed to Glen Cove thanks to someone who suggested it as it sounded like Glen Coe, an attractive spot in Scotland.

After this, in the 1850's, Glen Cove became a popular summer resort. There were many hotels, mostly near what is still known as The Landing, which was where the steamboat docked. Wealthy New York City residents looked to build estates near the water in Glen Cove. Some of these people included Charles Pratt, F.W. Woolworth and J.P. Morgan. And in 1867, due to Glen Cove's popularity with New York City residents, the Long Island Railroad was extended to that area. This expansion, in turn, made Glen Cove a great place to live year-round.

Soon enough, the Industrial Revolution hit Glen Cove and the Duryea Corn Starch Company opened. It employed a lot of residents, but some people did not like the business because it dumped waste from the conversion of corn to corn starch into the Glen Cove Creek, which, at times, caused a bad smell in both Glen Cove Landing and Sea Cliff.

However, due to all of the positive activity that was happening in Glen Cove, in 1918, it became an independent city and separated from the Town of Oyster Bay. The desire for tax revenues to be used in Glen Cove, considering it was a wealthy area and contributing quite a bit to the Town of Oyster Bay, was the main reason for this change. Not enough of the money was actually going to Glen Cove. It is now one of two cities in Nassau County, the other being Long Beach.

At this point, Glen Cove has its own police force, fire department and EMT service and is home to many wonderful sites like Garvies Point Museum and Preserve, Morgan Park, the Glen Cove Golf Course, the Holocaust Memorial and Tolerance Center, Pryibil Beach, Stanco Park, and Welwyn Preserve.

Instead of just seeing Glen Cove as the place "down the hill", we should get to know the city that so many of us are proud to call home.

Written and directed by duo Daniel Kwan and Daniel Scheinert, who are also known as "The Daniels", the story follows an immigrant mother, Evelyn, played by Michelle Yeoh, and her journey across the multiverse to defeat of version of her daughter found in a different timeline, Jobu Tupaki, played by Stephanie Hsu. Though the movie may sound confusing, deep down it is about the complicated relationship between a mother and daughter.

The movie's protagonist, Evelyn, is an overworked mother who is going through a midlife crisis. She feels discontent with her life, but finds it too hopeless to fix as she feels like a failure. She is having trouble with her marriage, her relationship with her daughter, Joy, her laundromat business, and her disapproving father. Evelyn constantly runs into problems and when she is overwhelmed, she dissociates "in another world in [her] mind" and struggles with focus. This was inspired by both director Kwan and his mother (NPR). Evelyn, as "a middle-aged immigrant person who has had a long life to look back on all [her] regrets" is constantly questioning "what if?" (NPR). As the story progresses, she needs to learn how to cope with the life she has, while she questions all the things that could have happened to her if she stayed in China or made different choices. She perfectly encapsulates the frustration, disappointment, and regret mothers feel, but even though her relationship with her daughter is strained, she still feels a never ending love for her daughter which will never change. For this role, Michelle Yeoh, who plays, Evelyn, is officially "the second nonwhite woman to win the Best Actress award in the Academy's near century of existence" (Ampil).

The movie also focuses on Evelyn's husband, Waymond, who is portrayed as a sensitive and kind man who questions his dysfunctional marriage. At the beginning of the movie, Waymond falls into the trope of the "beta male [who is] used primarily as comic relief" which is often a role Asian men are given (Magnuson). As the story progresses, the trope completely dissolves when Waymond succeeds in multiple ways where most other characters do not. He explains to Evelyn that the reason for his kindness is a "survival technique" that helps him "solves problems over time by just being kind"; he shows that he doesn't need aggression to fix situations and instead relies on kindness, which is a tactic that ends up working. Waymond is meant to destroy the trope of the weak, incompetent, beta man as he rejects the toxic masculinity most heroic male characters possess and ends up being a hero himself. The actor who portrays Waymond, Key Huy Quan, was awarded Best Supporting Actor for his incredible performance as he seamlessly switched between Waymond's varying personalities found in each timeline.

It really is no surprise that the movie is so popular. Even when switching between timelines, the film remains realistic in the characters intertwined relationships with each other; almost every human emotion is shown and as Evelyn accepts the life she has, the audience accepts it with her. Audiences are excited to see what the talented actors and directors are going to do next and the love for *Everything Everywhere All At Once* is well-deserved and can be felt around the world.

It has been confirmed that the beloved swan outside of the Swan Club, the event venue located at 90 Glenwood Road in Roslyn Harbor, is gone. The North Shore Masquers Present a Masterpiece By: Sophia Marchioli

The North Shore High School Masquers worked for three months on their latest production, Urinetown: The Musical, which was performed on March 24th and 25th. It focuses on a dystopian town which has a shortage of water and attempts to solve this issue by limiting a person's right to urinate: one must "pay to pee". This law is enforced by a large corporation named "Urine Good Company" which threatens citizens with banishment to the hellish "Urinetown" if they disobey the regulations placed on urination. Inevitably, this causes social and political conflict within the community, as many see the right to urinate as a natural human right. With long "grueling" hours, as director and advisor Aaron Brateman put it, the students worked hard to put the thrilling production together. Despite the tough process, cast members described the rehearsal environment as "enthusiastic" and "passionate".

This musical was carefully selected by Brateman for a few reasons. Last year, the director selected Hello, Dolly! as the musical because he felt it aligned with the idea that society was re-entering the world after the global pandemic. As one of the lyrics from the musical says, "It's so nice to have you back where you belong". Continuing with the theme of social relevance, Brateman selected Urinetown: The *Musical* because society must now consider how it will rebuild itself as the pandemic fades into the past. By bringing attention to issues such as corporate greed and inequality, the production tastefully forces the audience to acknowledge the world's flaws and ponder whether it's worth the sacrifice of creating social injustice for fiscal benefit. As lead, Hope, played by Charlotte Marchioli, says in a satirical tone, "Wow! I never knew large, monopolizing corporations could be such a source for good in the world!"

These messages were carried throughout the set design to create a cohesive story. Set designer, Margaret DeLima, stated that Brateman suggested that the set should reflect "a town with a history of corruption based on environmental politics, corporate greed, and social injustices, but also one similar to the French Quarter". Additionally, they put together grand puppets to be used as props which symbolized the "pageantry and spectacle of Mardi Gras parades".

Another distinct touch that the set design crew added was the curtain of water bottles which acted as the backdrop for the show. Made up of 5,100 plastic water bottles which were collected by The North Shore Masquers from mid-January to late February, the curtain aimed to mimic "the draping of Mardi Gras beads" as well as "flowing water" with its long, linked strands of bottles. This project proved to be a challenge for the crew as it attempted multiple methods of construction. Finally, after much trial and error, it landed on a method of lining up and taping "over 160 strands of bottles" together. DeLima stated that the curtain was used as a "strong metaphor for the monetization of basic needs as well as the ecological indifference of many capitalist enterprises". After having served their purpose, the bottles were recycled. Despite obstacles posed by the many regulations that sanitation facilities place on recycling plastic bottles, the Masquers were determined to have them recycled and to then donate any money collected from their recycling to water.org, an organization whose goal is to increase equality of access to clean and safe water.

With the intricate sets that were created, the actors then utilized these constructed spaces by making them look lived in, thus bringing life to the stage. This required an intense rehearsal process which asked cast members to be there almost every weekday from 3-6pm at the start of the process, and at the end of the process, every school day from 3-9pm and 10am-4pm on weekends. Brateman stated that in these rehearsals, he didn't just act as the leader, but as a "collaborator with the actor". When working with the actors, he claimed the biggest challenge that they faced came from the fact that the show is a comedy. As Brateman added, "comedy is infinitely harder than drama", and in this show it is even harder because of the "specific" and satirical nature of the comedy in Urinetown: The Musical. The actors had to go through a step-by step process to successfully depict the comedy that the show is meant to express. This started with identifying what exactly the script was making fun of, then fully committing to the comedy, and working as a team to create cohesion within the imaginative world that they were building. Ultimately, through many "glorious mistakes", as Brateman put it, the cast attempted to find "the most fun version of the show", and fully executed this goal by the time the curtain went up on opening night.

It is important to note that the construction crew and the cast weren't the only groups involved in the production. The production process also included, but was not limited to, the lighting and sound crews, the pit, or the musical accompaniment, and an external costume designer. Each group contributed to the complete cohesion of the musical, acting as the catalyst for the sea of smiles in the audience at every performance. The North Shore Masquers truly produced commendable work with their take on *Urinetown: The Musical*.

These mistakes were pointed out and spread on social media, "with fans pointing out the times it was laughably obvious that a stunt double had taken over a part" (Elite Daily). While fans are still excited for the next season to be announced, they are worried that more unpolished scenes will be put into OBX4. With the growth of new technology in the entertainment industry that allows media to be edited more easily, clips may not be looked over as thoroughly, which may be the cause of issues like these in TV series. Hopefully, the impending new season of OBX will be more carefully edited.

He was ultimately drafted to the Angels in 2018 and won AL Rookie of the year with 22 home runs, 61 RBI's, a .925 OPS and 4-2 with a 3.21 ERA. Ohtani then won MVP in 2021 as he hit 46 HR's, had 100 RBI's, a .257 BA, and a .965 OPS. As a pitcher he was 9-2 with a 3.18 era, 156 strikeouts. Mean-

Hofstra University's athletics have experienced tremendous success in the last few years. The University, located in nearby Hempstead, flies under the radar in terms of publicity, which is not surprising given the number of professional sports teams in the Tri-State Area. Nevertheless, Hofstra's athletic accomplishments serve as a source of pride for our community. In recent years, the school has witnessed success across both team and individual sports, including Men's Soccer, Women's Soccer, Men's Lacrosse, Men's and Women's Basketball and Men's Baseball. Hofstra competes in the Colonial Athletic Association (CAA) Conference with other schools such as Northeastern, Drexel, Stony Brook, University of Delaware, and William and Mary. The Women's Soccer Team sported the best conference record to win titles in 2021 and 2022. The men's team had its best season in 2021 by winning the regular season conference title and conference tournament. The team advanced to the NCAA tournament and racked up impressive victories over Lipscomb and Penn State before losing in the round of 16 to University of Pittsburgh. The core of the team returned for 2022 and won the conference tournament in order to participate in the NCAA tournament. Unfortunately, the team lost to the higher-ranked University of South Florida. 12 SPORTS Addressing The Quarterback Situation Yet Again

By: Michael Ye The 2021-22 NFL season was considered rock bottom for New York football. Both the Giants and Jets found themselves finishing last place in their respective divisions with measly 4-13 records, causing both fan bases to look ahead to the draft before the playoffs even began. After experiencing such a low quality on-field product, expectations were kept in check coming into this past season. It was viewed more as another step in each team's rebuilding process and a chance to see the growth and development of young players. Both teams however, were able to accomplish a lot more than expected. The Jets were able to stay competitive throughout the season and finish 7-10, while the Giants went 9-7-1 and ended up winning a playoff game against the Minnesota Vikings. Such a pleasant surprise has left fans wanting more. With the direction of both teams trending upwards, making acquisitions this offseason was the clear next step. So what have they done so far and will it be enough to make them legitimate playoff contenders next season?

As encouraging as this past season was for the Giants, it's obvious that their playoff caliber record was a fluke. They had one of the easiest schedules in the league, which allowed for six of their nine wins to come against teams with losing records and two of them to come against playoff teams that got eliminated in the first round. Beating up on teams tanking for a higher draft pick along while performing well against the Vikings' defense that had many holes are tasks that Daniel Jones was able to complete, which made him look like the long term solution at quarterback. After having his fifthyear option declined before the season, Jones was set to become a free agent. He picked the perfect time to have a career year, throwing for 3,205 yards, rushing for 708 yards, scoring 22 total TDs, and throwing just five interceptions to create a passer rating of 92.5. With this, the Giants essentially had no choice, but to retain him considering they didn't have a high first round pick like the year before to replace him. All of these circumstances resulted in Jones receiving a four-year \$160 million contract extension, one that he most definitely does not deserve. A contract like this only proves how inflated the quarterback market has become due to the scarcity and desperation of teams that are unable to find their answer at the position. Any competent quarterback is now able to demand between \$30-40 million a year once he hits the open market. The Giants just so happened to be the next victim of this, resulting in Jones now being the seventh highest paid quarterback on an average annual value basis. The reality is that he is nowhere near a top ten player at the position and should have been franchise tagged.

There are two main arguments against this hypothetical transaction, both of which are valid. The main reason fans have for justifying this extension is because it gives Jones a lower cap hit for this upcoming season; the franchise tag for quarterbacks is worth \$32.4 million while Jones is set to have a cap hit of \$21 million. This is a fair point due to the cap flexibility it gives the team right now, but it completely ignores the fact that Jones will now have a cap hit of \$45 million the following season and \$39.5 million the year after that with an \$18 million dead cap penalty if the Giants choose to cut him. With the current state of this team, it is by no means in "win now" mode and is sacrificing years two to four of this contract for only next season. Placing the franchise tag on Jones would prevent overpaying him and force him to prove more in order to be worth franchise quarterback money. The second argument fans make is that the franchise tag would instead be used on running back Saquon Barkley, who is also coming off a stellar year where he rushed for 1,312 yards, 10 TDs, and averaged 4.4 yards per carry. Like the first argument mentioned, this one also makes sense. The running back position is such a replaceable one to the point where teams can either use a mid-round pick or sign cheap veterans to get the job done. Barkley also has an injury history and is now 26 years old, which is considered "old" for a running back due to the physicality they endure every time they touch the ball. The difference between these two players however, is that Barkley is a proven elite player that is clearly one of the best at his position, while Jones is just average. If anything, Barkley deserves a contract extension more than Jones does. Moreover, Barkley has already refused to sign his franchise tag and wants to get paid a longterm extension. This mismanagement by the Giants' front office not only keeps them fighting for third place in the NFC East Division, but also compromises their future.

The team's best move this offseason however, was trading a third round pick to the Las Vegas Raiders in exchange for Darren Waller. This was a great trade for the Giants, as Waller is an elite tight end who is one of few left at the position that can consistently produce in the receiving department. While he has dealt with injuries over the past two years, it shouldn't overshadow his consecutive 1,100 yard seasons the two years prior. Waller is a matchup nightmare who has the versatility to line up in the slot, which makes sense considering that he was drafted as a wide receiver before converting to tight end. With how weak the Giants' receiving options are, he immediately becomes Daniel Jones' number one target and should bounce back to being an annual 1,000 yard producer. Additionally, the Giants were also able to strengthen their linebacking core by signing Bobby Okereke to a four-year \$40 million contract. He is coming off of a solid year with the Indianapolis Colts, where he missed just 6.8% of his tackles and allowed a completion percentage of 70.7% and a passer rating of 91.3 to earn a PFF Grade of 73.3. With how little acquisitions the Giants have made over the past few months, Okereke will be the most impactful one and improve the weakest part of the defense.

Moving over to the Jets, they also had an off-season full of drama at the quarterback position. With the entire fanbase turning on former second overall pick Zach Wilson, the team was clearly willing to cut its losses and 'swing for the fences'. The dream was set on day one: go trade for a disgruntled Aaron Rodgers and turn the team into Super Bowl contenders. After years of tension between him and the Green Bay Packers' organization, they finally agreed to part ways after over a decade of success together. On paper, Rodgers is coming off one of the worst years of his career. He threw for just 3695 yards and had a touchdown to interception ratio of 26 to 12, amounting to a

passer rating of 91.1 While it may seem like the cause of such regression is due to his age, it's obvious that he didn't have any help around him. The team lost Davante Adams, who was arguably the best receiver in the league in the prior offseason and was left with a bunch of rookies and replacement level players as receiving options. No quarterback can succeed under those conditions, and it was the 'last straw' for Rodgers. After months of speculation and waiting, the Jets and Packers finally agreed to the big trade a few days before the draft. It involved the two teams swapping first round picks, along with the Jets giving their second-round pick this year and a conditional second-round pick next year that will most likely turn into a late first-round pick. Considering how little leverage Green Bay had in this situation, they got a pretty solid return for a 39-year old player. The Jets however, came away with who is now their best quarterback in franchise history. Even though this is only one move, it is completely fair to expect the Jets to compete with the Buffalo Bills for the AFC East Division title next season.

All of this drama has completely overshadowed the fact that the Jets have done little to nothing when it comes to improving other parts of the team. The team's biggest free agent signing was bringing in Allen Lazard on a four-year \$44 million contract. It's obvious that this move was only done to convince Rodgers to come play for the Jets, as Lazard was his number one receiver last year. While the two have built up chemistry together, the issue is that this was a complete overpay for someone who only provides value in the run blocking department.
